AN ORDINANCE REZONING 1630 JOE GOLDSBOROUGH ROAD (TAX MAP ID: 1502200143) FROM NC21 – RESIDENTIAL IN NEW CASTLE COUNTY TO THE ZONING DESIGNATION OF INSTITUTIONAL AND RECREATIONAL (I&R) IN THE TOWN OF SMYRNA

WHEREAS, the Town Council of the Town of Smyrna is authorized pursuant to 22 *Del. C.* Chapter 3 and Section 4.2.37 of the Town Charter to enact zoning regulations in the town;

WHEREAS, the Smyrna Church of Christ, Inc. is the owner of a property known as 1630 Joe Goldsborough Road, Smyrna, Delaware (Tax Map ID: 1502200143) and desires to rezone the parcel from NC21 – Residential in New Castle County to Institutional and Recreational (I&R) in the Town of Smyrna;

WHEREAS, the property is designated on the Future Land Use Map of the Town’s Comprehensive Plan for institutional use, which designation is consistent with the proposed zoning classification of Institutional and Recreational (I&R);

WHEREAS, Sections 13 and 14 of the Zoning Code of the Town of Smyrna require amendments to the Zoning Map of the Town of Smyrna to be submitted to the Planning Commission for “report and recommendation” after holding a public hearing;

WHEREAS, the Planning Commission held a public hearing on August 28, 2024, at which time the Planning Commission recommended approval of the proposed rezoning; and

WHEREAS, in the opinion of the Town Council, rezoning 1630 Joe Goldsborough Road, Smyrna, Delaware (Tax Map ID: 1502200143) from NC21 – Residential in New Castle County to Institutional and Recreational (I&R) in the Town of Smyrna will be consistent with the Comprehensive Plan and in harmony with the zoning of the other properties in the surrounding area, is in the best interest of the Town of Smyrna, and is necessary for the public health, safety, and welfare.

NOW THEREFORE, BE IT HEREBY ENACTED by the Town Council of the Town of Smyrna, a majority thereof concurring in Council duly met, that 1630 Joe Goldsborough Road, Smyrna, Delaware (Tax Map ID: 1502200143), including the adjacent rights-of-way to the centerline thereof, is hereby rezoned to Institutional and Recreational (I&R) in the Town of Smyrna and that the Town of Smyrna Zoning Map be amended to reflect this rezoning.

SYNOPSIS

This ordinance rezones 1630 Joe Goldsborough Road, Smyrna, Delaware (Tax Map ID: 1502200143), including the adjacent rights-of-way to the centerline thereof, from NC21 – Residential in New Castle County to Institutional and Recreational (I&R) in the Town of Smyrna.
